GENERAL CONDITIONS OF SERVICE
(DOCUMENT TO KEEP WITH CARE)

In order to help willing users to **get the best prices** to have the pretreatment structures of their non-collective sanitation installations drained, la Communauté de Communes Isle et Crempse en Périgord made a deal for the draining planned of the pretreatment structures of non-collective sanitation installations. **Every user is free to have recourse to this service.**

This basic service includes :

- general organization of the mission (sending of mails to make appointments, intervention planners....),
- participation in any potential meeting that would be necessary to every campaign,
- the business trip on location including its price,
- the implementation of necessary human and material means,
- provision and installation of necessary pumping pipes,
- rodding and cleaning of pretreatment structures (greasing tank, prefilters, and other things),
- starting of filling water into the tank (the user provides water),
- transportation and emptying of muds removed on an authorized location whatever the distance between the location of emptying be,
- implementation and the transmission of the tracking note for drainage materials.

Other services are also offered, maintenance of a prefilter independent from the tank, drainage of a degreasing tank only that includes transportation and removal of greases in an authorized location

If the user wants to have recourse to one of these services, he/she agrees to make an order with the Communauté de Communes Isle et Crempse en Périgord. Following that order, the SARP SUD OUEST ALANIOU, drainage company chosen by the Communauté de Communes Isle et Crempse en Périgord shall confirm it by mail at least 15 days prior to the date of intervention, the correct date of the intervention.

Drainage will be performed in the presence of the owner and/or tenant or his/her representative. For any intervention ordered but impossible to perform on land (inaccessible manholes, unlocated...) and business trip made, a business trip fare will be invoiced and its amount has been defined in the deal (€50)

Once on the location, the drainer shall establish a tracking note stating drainage and specifying the date and the services performed depending on the real conditions on location. This note shall be issued in 2 copies and signed by the user or his/her representative. The user shall be given a copy and the Communauté de Communes shall be given a copy.

The user shall have a one-month notice, from the day of drainage, to express possible observatio

Obligations of the user

The user agrees to:

- Be present during the intervention of the service provider. In case it is impossible for him/her to be present, he/she shall appoint a representative who shall be present on the day and at the hour settled with the provider,
- Make the access to nominated property easy,
- Make pretreatment structures of the non-collective sanitation accessible. Every manhole shall be open and released during the intervention of the service provider,
- Provide enough water to fulfill the tank,
- Sign the tracking note that specifies the final amount for the intervention depending on the real conditions on location,
- Pay the invoice of the intervention directly to the service provider

Obligations of the service provider

The service provider agrees to :

- Respect the provisions defined in the documents of the deal signed with the Communauté de Communes Isle et Crempse en Périgord,
- Provide all documents required for the good proceedings of the deal.

Obligations of the Communauté de Communes Isle et Crempse en Périgord

The Communauté de Communes Isle et Crempse en Périgord agrees to :

- Watch over the good proceedings of the deal during all the time of the service,
- Provide the service provider with all the elements required for the good proceedings of the deal.
